**Earls Gate Water Ltd's Application for Water Services and Sewerage Services Self Supply Licences**

1. Part B of the standard conditions shall be suspended and cease to have effect in your licences, consistent with standard conditions B1(7) and B2(4).
2. Part C of the standard conditions shall have effect in your licences, consistent with standard condition C1(5).

For the avoidance of doubt, you are still required to comply with all other applicable licence conditions, including Part A of the standard conditions and any ordinary conditions.


